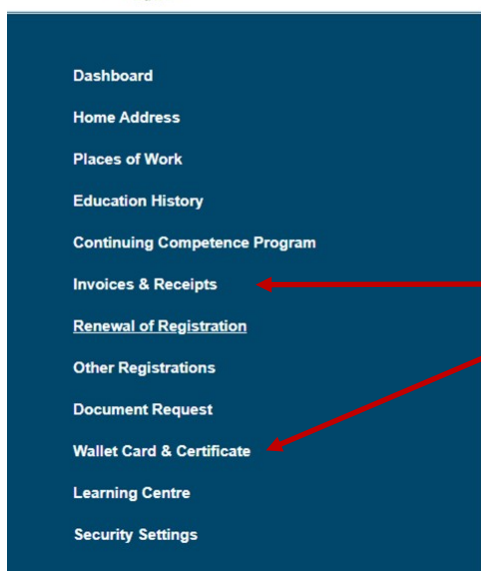
## Holiday Hours

## Research Projects

**PEI NP Practice Analysis** — This survey examines the practice activities and patterns of NPs in PEI with the goal to develop the knowledge needed to inform decisions related to optimization of the NP role in the health care system.

**UNB** — Researchers at the UNB Centre for Criminal Justice Studies are seeking intimate partner violence (IPV) professionals to complete a 15-20 minute survey evaluating the process of IPV risk assessment and the effect of risk assessment training on that process.

**U of Calgary** — Knowledge and Attitudes about Pharmacogenetic testing study, this study aims to understand the background knowledge and attitudes of pharmacogenetic testing among nurses and nursing students.

Did you know that if you have a change in name, (marriage, divorce, etc.) it must be reported to the College within 30 days? You cannot practice or sign using a name that is different from the name that appears on your Certificate of Registration.

## Continuing Competence and Database

During Renewal you started a 2020-2021 Continuing Competence Plan. You can update and make changes to it throughout the year. By updating it regularly, you will decrease the amount of work needed at renewal time next year.

All new Registrants since November 1, 2020 should go in and start a CCP for this registration year, 2020-2021. By doing so now, you will avoid having to do two at renewal next year.
